Discuss mandatory vaccinations for covid-19.

Information coming to parents tomorrow with some additional information about covid19, via email and will be available through website.

What may happen if there is a suspected case at school:

- Student: they will be asked to isolate at front of school, wear a mask, parents will be called to collect student
- Teacher / staff / essential visitor: put a mask on and leave the presmises

A report will be made to the Directorate and they will guide process

If there is a case confirmed at the school, ACT Health and Directorate will determine the process of who is impacted, what areas shut down. School is not in a position to make decisions on closing the school, ACT Health have thorough and procedures guidelines to follow. Information will go to the community as quickly as possible if that happens.

Students yr 7-12 required to wear a mask. Years 3-6 are encouraged to wear a mask. Teachers / all adults will be wearing masks on site. There may be some students and teachers who are exempt and they are being catered for.

### Questions -

? Parents entering school? Reading assistance, volunteering etc?

A – essential visitors can come to school but volunteers is a topic for the future. Will be following up on vaccination status on essential visitors

? opening windows etc, reduce possibility of an outbreak. Have the rooms been inspected? CD monitors?

A – monitors not bring used, windows have been inspected, chains that limit opening, windows painted shut have requested assistance from Directorate mainly in regard to disturbing lead paint. Doors will be left open during class time.

#### ? Air con

A – School is speaking to Infrastructure and Territory Services in regard to air conditioning improvements.

? children in year 6 who are 12, or others who wish to wear masks

A – Jason and David will be talking to students on return about a choice to wear a mask. Students are not to harass, hassle, give a hard time to others about masks.

? Timing of classes, if other children are being dropped off which may clash with online classes.

A – working with primary, some children may be late and that is OK. Looking at attendance and ensuring students and teachers are in touch in a regular manner.

Community questions

 Can we (per Edu Directorate) keep children home who are unvaccinated, until they are vaccinated? If so, will remote learning materials be provided? How would families apply for this?

If parents choose not to return children to school, let the school, teachers, and admin teams know and it will be recorded as reasonable leave.

Years 3-10, google classrooms will be accessible. Year k-2 class dojo will have some material.

It is recognised that teachers can't do both. Some work will be provided but it will not be at the same level. Some feedback from teachers will be possible but it won't be the same as the remote learning period.

Protocol should be accessible on the website.

- School Covid Safe plan seems to be inaccessible, can we have a copy emailed rather than having to log in.

The individual has received an email.

Please let the school know if anyone doesn't get the information, it is critical that all families receive the information.

Canteen update

No update from school. Jeannot spoke to Directorate. The Directorate have said they have put applications out, only one applicant was suitable, and more information is required from that applicant. Term 4 there will not be a provider, but hopefully by Term 1 2022 there will be a new provider.

The provider looks like a great option but a few hoops to go through.

Telopea being an older school, ventilation has been a problem both in summer and winter. As we understand it an audit was conducted during the fires and the school was deemed to have adequate ventilation. Are you able to elaborate on how ventilation will be sufficient given has regularly had issues since the fires?

- It would be good to know what the plan is if a child/teacher/other school staff tests positive Addressed above
  - Is the school planning to use rapid tests (once they're finally approved by the government) from what I can see from Europe, these tests are pretty accurate when the patient has
    symptoms if a child or someone else at the school had symptoms, it'd be good to know
    whether he/she's Covid positive within 15-20 min rather than have to wait for 24 hours.

Will take Dep Health advice on this, with Edu Directorate. It is not up to the school to use or rely on these tests.

Resilience project / school wellbeing

President will talk to Jason about Resilience project.

School response – we are seeking support from Directorate. Teachers will be checking on students regularly. Will be accessing Directorate support services and Telehealth, will be talking to a lead psychologist about what other services are accessible.

- Parents night out

President is a strong advocate for giving back to the community and encouraging connections amongst the community. Will organise once restrictions allow will attend.

- 100 Year Celebration

Community / previous students have reached out to the P&C. School is considering and wishes to involve Alumni. Put the comms person from the school in touch with these Alumni who are in touch. School will be looking to the P&C for support for a wonderful event.
